

Tierra Vista Pet Policy



The following animals are allowed in our home:
Two Pet Limit: one cat & one dog, two dogs, or two cats

- Cats: Domestic only
- Dogs: Excluding those that are a restricted breed
- Fish: 20 gallon tank maximum
- Birds: Excluding birds of prey
- Amphibians: Frogs, toads, salamander
- Caged Animals: Hamsters or guinea pigs
- Crustaceans: Hermit crabs, crawfish, shrimp

Any dog (of any breed) that demonstrates a propensity for dominance or aggressive behavior as indicated by any of the following types of conduct:	<ul style="list-style-type: none"> ● Unprovoked barking, growling or snarling at people approaching ● Aggressively running along fence lines when people are present ● Biting or scratching people ● Escaping confinement or restriction to chase people
Reptiles	Ex: Snake, lizard, turtle, tortoise, crocodile, alligator, iguana, komodo dragon, newt, gecko, gila monster
Arachnids	Ex: Spider, scorpion
Rodents	Ex: Mice, rat, gerbil, mole, beaver, squirrel, porcupine, chipmunk, prairie dog, groundhog, gopher, shrew, bat, hedgehog
Wild animals	Ex: Fisher cat, fox, weasel, raccoon, monkey
Exotic animals	Ex: Ferret, rabbit, chinchilla
Farm animals	Ex: Pig, horse, cow, chicken, sheep, goat
Birds of prey	Ex: Hawk, eagle, buzzard, vulture, owl, falcon, harrier, kite

By signing below, I understand pet ownership is a privilege and the following conditions apply:

- There is a one time non-refundable \$200 pet fee per dwelling due at move-in. This is intended to cover the cost of the de-fleaing, deodorizing and shampooing of the carpets within the home at Move-Out. Resident is responsible for additional pet damage costs to the home at move-out.
- Shot records must be turned into the Community Center and be kept up to date.
- Pets must not disturb neighbors and residents whether inside or outside the home. After three complaints of an animal, the animal must be removed from the home.
- All pets must be housebroken. All pet waste must be cleaned immediately from your private yard and common areas.
- Pets must not be tied to any fixed object anywhere outside the dwelling.
- Pets are not allowed on any recreational facilities including play grounds, community centers etc.
- Pets are required to remain leashed at all times while not in the confines of your private yard.
- We reserve the right to remove an animal from a home if the following conditions are met:
Abandoned animal; Failure to care for animal; Aggressive animal.
- You are responsible for any damage cause by your pet or any visiting pet to your home or any property belonging to Tierra-Vista. In addition, you are held liable for any personal injury that occurs to any person as a result of your pet.
- If you have a Permission to Enter on file for maintenance work and your pet is not kenneled in your absence, the maintenance work will not be performed.
- In an emergency involving an accident or injury to your pet, we reserve the right, but not the duty, to take the animal to the Emergency Veterinarian listed above at your expense.
- If a support animal is needed, please speak to a community representative regarding the animal.
- If at anytime you, your occupants or a guest violate the above, we reserve the right to revoke your pet privileges. You will be notified in writing and the pet must be removed immediately.
